### **Contest Rules**

- 2. Entries should be a minimum of 500 and a maximum of 750 words and must address the theme: "Concerns About Recreational Marijuana/THC Use and Driving"
- 3. The Missouri Peace Officers Foundation readily acknowledges that spelling, punctuation, and proper grammar are important in essay construction. However, for purposes of this contest, judging emphasis will be placed on the content and message of each entry.
- 4. Entries must be typed. The student's name, class hour, and teacher's name must be on page one of each essay.
- 5. All entries must be submitted with a completed entry form. The form is on the back of this pamphlet and may be photocopied.
- 6. For each school participating in the contest, MPOF requests that the principal or instructor select and submit *only the three best essays* from each class hour that is participating. *Entries must be reviewed by the principal or instructor to be eligible.*
- 7. All entries must be received no later than February 21, 2024. All winners will be notified through their schools, by phone or mail.
- 8. Entries become the property of the Missouri Peace Officers Foundation. Entries will not be returned, and the Foundation is not liable for lost or missing entries.
